A tax rate of \$0.026013 per \$100 valuation has been proposed by the governing body of The Port of Harlingen Authority.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for The Port of Harlingen Authority from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that The Port of Harlingen Authority may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that The Port of Harlingen Authority is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 15, 2022 AT 12:00PM AT PORT OF HARLINGEN AUTHORITY OFFICE, 24633 PORT RD, HARLINGEN, TX 78550.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, The Port of Harlingen Authority is not required to hold an election to seek voter approval of the rate. However, support for, or opposition to the proposed tax rate can be expressed by contacting the members of The Port of Harlingen Authority Board of Commission at their offices, or by attending the public meeting mentioned above.
